










FLOOR PLAN



















TYPE A (E) 4 Bedroom 2 Bathroom 1053sf


7 Bedroom 3 Bathroom 1800sf





6 Bedroom 4 Bathroom 1624sf




PENTHOUSE LOWER FLOOR PLAN
